Dear Sir or Madam:

This is an administrative appeal of the denial of my July 15, 2013 FOIA request, control number 071620137079, denied by Hugh Gilmore's letter of February 25, 2015 citing Exemption 5 of the FOIA (5 U.S.C § 552(b)(5)). The documents requested in this FOIA have been released to over 450 Accountable Care Organizations (ACOs) for further dissemination to beneficiaries. The denial letter says there are 17 pages.

Mr. Gilmore's reference to Exemption 5 did not cite to any specific privilege. Although he made conclusory mention of attorney-client privilege and the deliberative process privilege, he did not explain how either applies to information already released to the public. The documents are not pre-decisional, since Medicare has approved them for release to ACOs and beneficiaries. The documents cannot contain recommendations on legal or policy matters, since their purpose is to tell beneficiaries factual information about ACOs.

I understand Exemption 5 to embody the Deliberative Process Privilege, Attorney Work-Product Privilege, Attorney-Client Privilege, Confidential Commercial Information, Statements from Air Crash Investigations, and Reports of Expert Witnesses.

None of these privileges bears in any way upon my request, because I sought information listed in 76 *Federal Register* 67946-67947, 11/2/11, which the regulated entities, ACOs, must use to communicate with beneficiaries, including:

- "post... to notify beneficiaries" 42 CFR § 425.312(a)(2)
- "Make available standardized written notices" 42 CFR § 425.312(a)(3)
- "Use template language developed by CMS" 42 CFR § 425.310(c)(1)

A claim of privilege by definition cannot attach to information that is to be "made available" to the public. Moreover, "standardized" language that is already provided to third parties is inherently inconsistent with the notion of the types of information that privileges are intended to safeguard.

CMS has improperly misapplied exemption (b)(5), saying that no portion of the 17 pages of responsive documents can be released to me, though they have been released to over 450 ACOs (Attachment 3) for dissemination to beneficiaries. Even while this FOIA was pending, CMS released the documents to 122 ACOs which started in January 2014, and 89 which started in January 2015.

I respectfully request that CMS rule upon this FOIA Appeal within 20 days as required by law. Should CMS continue to withhold any of the 17 pages, I request that CMS provide an itemized, indexed inventory of every agency record or portion thereof responsive to my request which CMS asserts to be exempt from disclosure, accompanied by a detailed justification statement covering each refusal to release records or portions thereof.

I am amenable to resolving this matter and encourage you to contact me at the address above. If we are unable to resolve this administratively, I am prepared to pursue the matter in district court.
